

AN ECONOMIC REPORT ON NATIONAL PARKS BY STATE

ABOUT THIS REPORT

This summary organizes the data presented by a National Park Service Report on Visitation and Usage from 2023. That report provides a thorough analysis of the economic benefits of National Park System (NPS) visitation, and it is authored by Matthew Flyr and Lynne Koontz, who should be credited for the majority of the content included herein. This report was



organized by Deanna Lynn Wulff, Unite for Parks Executive Director.

In this summary, each state has a chart of its national parks and their economic benefits and employment implications, such that decision-makers, leaders, senators, and congressional staff can easily discern the direct effects that national parks provide in terms of the number jobs and the value of conservation.

While this report is based on 2023 visitor use information, in 2024, National Parks received more 331.9 million visits, more than ever before; this is an increase of 2% in visitation. Thus, the estimates shown in this summary are understated. Also, national scenic and historic trails such the Appalachian Trail, the Lewis & Clark Trail, and the North Country Trail, which are managed by the NPS and are regularly patrolled and maintained do not have visitor usage statistics; only the Ice Age National Scenic Trail began recording visitation in 2021, so this information is not included in this report. In addition, some smaller park units do not have data available; only 404 out of 433 Park Units were measured. In these cases, the excluded units are noted in the text for each state.

The National Park Service manages 433 official units, including 63 major national parks. These units include national parks, historical sites, monuments, and preserves, and affiliated areas that are not part of the official unit list, and include national scenic trails, rivers, ports, forts, and islands. In instances in which national parks cross multiple state boundaries, the



economic statistics are totaled as a percent of the park in state territory. For example, the Blue Ridge Parkway crosses Virginia and North Carolina, and the net benefits are divided accordingly.

The National Park Service's purpose as determined by the Organic Act of 1916 is "to conserve the scenery and the natural and historic objects and the wild life therein and to provide for the enjoyment of the same in such manner and by such means as will leave them unimpaired for the enjoyment of future generations." That purpose focuses on preserving the natural world and our shared cultural heritage, but the benefits of conservation of the public's shared lands to the American economy and people are profound.

KEY FACTS ABOUT OUR NATIONAL PARKS

- For every dollar invested in the Park Service \$11 go back into the economy.
- In 2023, the NPS generated \$55.6 billion in economic output and supported 415,400 jobs.
- The NPS operating budget is only 1/2000 a percent of the average U.S. annual budget.
- American patriotism and trust in institutions—especially those of government—have plummeted in recent years,² but not for the National Park Service. The park system enjoys more public support than any other federal agency or department.
- More than 75 percent of Americans view the Park Service favorably, an approval rating that is impressive in light of its consistency across the political spectrum.
- Both Republicans and Democrats have supported, endorsed and helped create and grow the National Park System;³ national parks are a bipartisan ideal and value, from Abraham Lincoln to Theodore Roosevelt to George W. Bush and Jimmy Carter, all have contributed to its growth.


USER VISITATION DATA 2024 UPDATE⁴

- The National Park Service reported a record 331.9 million recreation visits in calendar year 2024. This is an increase of 6.36 million recreation visits, or 2% from 2023.
- There was a 2.6% increase from 2023 for overnight stays in concession and NPS operated facilities. Overnight stays at concession operated lodging alone were up 11.7%.
- 404 of the 433 National Parks report visitor use. Four new parks began reporting in 2024.
- 28 parks, 7% of reporting parks, set a record for annual recreation visits.
- Visitors are spreading out their visits throughout the year. 55% of parks experienced an above average number of visits in February-June and October-December.
- 38 parks experienced visitation above the 10-year average in every month of the year.
