AN UPDATE ON OUR NATIONAL PARKS CONDITIONS

ABOUT THIS REPORT

This report organizes the data presented by a [National Park Service spreadsheet](#), which details park conditions as of July 2025, in the aftermath of the hiring freeze, terminations and early retirement offers, and reduced staffing and funding for America's National Parks.



In this summary, each state has a chart of its national parks' economic benefits and employment implications, such that decision-makers, leaders, senators, and congressional staff can easily discern the direct effects that national parks provide in terms of the number jobs, the value of conservation, and the effects of budget cuts.



For this report, however, not all parks reported in with the budgetary effects, so the information here presents a partial view into the outcome of terminating thousands of rangers, offering early retirement, and instituting a hiring and funding freeze.

To fund our national parks, takes only 1/2000 a percent of the federal budget on average and keeps 415,000 people at work via associated consumer spending while preserving and protecting America's great landscapes.

KEY FINDINGS OF JULY 2025 REPORT

- **38 States were affected by budget or staff cuts** to the National Park Service – 76 Percent.
- **Parks lost millions of dollars** because they were unable to staff entrances and collect fees, including major parks such as Grand Canyon, Glacier & Zion.
- **20 percent of the country's 433 parks** were strained and understaffed.
- **The NPS lost 24 percent of its permanent employees.**
- **More than 90 national parks reported problems** between April- July.
- **Routine work went undone**, like cleaning and stocking the bathrooms, taking out the trash. Visitor Centers were closed or hours were reduced.



PARK HIGHLIGHTS



- Nine [Washington DC Parks](#) were affected by cuts including the popular Rock Creek and the National Mall – Bathrooms were closed. Trash wasn't regularly picked up. Homeless encampments weren't cleaned up. Hundreds of hazard trees were not removed.

- At [Zion National Park in Utah](#), the lack of staffing at fee entrance stations is projected to add up to \$2 million in lost revenue this year,

according to park figures as of late July.

- [Glacier National Park in Montana](#) is now relying on the honor system to collect entrance fees, asking visitors to pay using a QR code.
- At [Harpers Ferry National Historic Park](#) in West Virginia, the park can't bring on willing volunteers because it can't hire someone to manage them. Each year, nearly 300,000 volunteers collectively contribute more than 6.5 million hours of volunteer service at our national parks.
- [Lassen Volcanic National Park](#), in the mountains of Northern California, was unable to hire custodians, leaving the maintenance staff to handle custodial, trash, water, electrical, plumbing, and carpentry needs.
- At [Fort Scott National Historic Park](#) in Kansas, Children's Programs and Educational Tours, & School Field Trips were cancelled. Restrooms closed.
- At [Mount Rainier in Washington State](#), campgrounds and visitor centers delayed openings, and visitor services were reduced.

Please note: Some vacancies at parks predate the Trump administration, but the hiring freeze prevents parks from filling them. In addition, parks typically hire about 8,000 seasonal employees each year, a process that starts in the winter. But as they contended with the push to reduce permanent staff, the parks hired a little more than half of the workers they usually bring on during the busy summer season.

No one has been nominated to run the National Park Service, an agency that is part of the Interior Department.



KEY FACTS ABOUT OUR NATIONAL PARKS

- For every dollar invested in the Park Service - \$11 go back into the economy.
- In 2023, the NPS generated \$55.6 billion in economic output and supported 415,400 jobs.
- The NPS operating budget is only 1/2000 a percent of the average U.S. annual budget.
- American patriotism and trust in institutions—especially those of government—have plummeted in recent years,¹ but not for the National Park Service. The park system enjoys more public support than any other federal agency or department.
- More than 75 percent of Americans view the Park Service favorably, an approval rating that is impressive in light of its consistency across the political spectrum.
- Both Republicans and Democrats have supported, endorsed and helped create and grow the National Park System;² national parks are a bipartisan ideal and value, from Abraham Lincoln to Theodore Roosevelt to George W. Bush and Jimmy Carter, all have contributed to its growth.

USER VISITATION DATA 2024 UPDATE³




- The National Park Service reported a record 331.9 million recreation visits in calendar year 2024. This is an increase of 6.36 million recreation visits, or 2% from 2023.
- There was a 2.6% increase from 2023 for overnight stays in concession and NPS operated facilities. Overnight stays at concession operated lodging alone were up 11.7%.
- 404 of the 433 National Parks report visitor use. Four new parks began reporting in 2024.
- 28 parks, 7% of reporting parks, set a record for annual recreation visits.
- Visitors are spreading out their visits throughout the year. 55% of parks experienced an above average number of visits in February-June and October-December.
- 38 parks experienced visitation above the 10-year average in every month of the year.

Cause	Birmingham Civil Rights National Monument
Staffing Shortage	<ul style="list-style-type: none"> Reduced ranger led-tours. This is a new park that has continued to experience staff hiring and capacity challenges, while visitation to the Civil Rights District has steadily increased. The A.G. Gaston Motel operates with two park rangers. The federal government hiring freeze has prevented BICR from hiring two GS-5 park guides. Due to staffing (2 park rangers), ranger-led tours will be limited.
Cause	Freedom Riders National Monument
Staffing Shortage & Building Conditions	<ul style="list-style-type: none"> Visitor Center Hours Reduced due to short staffing through much of 2024. Regular staff is currently one park ranger. No issues were previously reported but there is a new issue. The Visitor Center was closed due to a failure of the HVAC system and high heat index. A replacement cooling system was ordered but has not yet arrived. It is anticipated the replacement unit will be delivered and installed in the next few weeks. The visitor center will reopen when the cooling has been restored.
Cause	Horseshoe Bend National Military Park
Staffing Shortage & Storm Damage	<ul style="list-style-type: none"> Two Roads Closed. The Tour Road and Nature Trail were destroyed by EF3 Tornado. The tour road is partially closed due to EF3 tornado damage in the park. This issue is still occurring and is unchanged. Park staff have developed plan to mitigate aerial hazards and clear debris by hand that is appropriate for archeological site. Reduced staffing due to deployment to support GRCA and VIIS, staff on military active duty and limitations on travel and budget have hindered recovery timeline. The tour road may open by the end of FY25. The park has been awarded an AmeriCorps team arriving Nov 2025, which will benefit recovery efforts and increase visitor access.

The park currently has \$1,015,540 in BSD funding for the hiring of public safety positions and \$840,022.13 in funding from GRG for custodians and maintenance workers that cannot be used due to the hiring freeze. BSD funded Security Guards operate magnetometers and x-ray machines, and manage building access, as required by JEFF's Icon status. These positions are highly specialized and require a Tier 3 (Secret) background investigation, which adds 3-6 months of lead time to the onboarding of guards. While exempt from the hiring freeze, our guard program is short staffed because of the NPS HR consolidation, which diminished our ability to hire positions quickly. A guard cert was also cancelled on January 22, creating a critical shortage of guards for the summer season. On January 24, we requested the re-instatement of the certificate of eligible candidates for security guard positions, but that exemption was not approved, and the guard cert was not re-instated. Current guard staffing is not sufficient to run 2 shifts a day and staff the security checkpoint from 9 a.m. – 8 p.m. without significant overtime. We call staff in and pay overtime when someone calls in sick or takes scheduled leave. Further, JEFF attempted to issue a contract for security guards in 2024 to supplement guard staff and increase efficiency. NPS contracting stated that Federal Acquisition Regulations prohibited hiring contractors for work currently being carried out by Federal employees.

	<ul style="list-style-type: none"> BSD funded Arch Tram System (ATS) mechanics repair and maintain the ATS, ensuring the safe operation of the ATS, which transports over a million visitors a year to the top of the Gateway Arch. One ATS mechanic is currently vacant due to the hiring freeze and 1 more will become vacant in late April 2025 due to a removal for misconduct. The park needs these positions filled to fully operate the tram system during the busiest days of the summer season. GRG funded maintenance workers maintain critical life, health and safety systems in the Arch visitor center and ranger station such as HVAC, security bollards (required by Icon security to prevent vehicle access by terrorists), electrical systems, and fire suppression. GRG funded custodians maintain public areas such as the Arch visitor center, entrance lobby, tram lobby, museum and restrooms (restrooms will be address separately in the next section). Due to a lack of staffing in these divisions, we will be unable to extend our summer hours 7 days a week this year. Instead of being open from 9am - 8pm Mon-Fri, this summer we will be open from 9am-8pm on Fridays and Saturdays, and open 9am-6pm Sunday-Thursday, maximizing visitor access and enjoyment during the highest visitation times and allowing us to reduce the number of shifts per day from 2 to 1 shift in our custodial, guard and Arch Tram System programs. Without reduced hours, we will not have sufficient staff to stay open 7 days a week. If the certs are restored for our two guard positions and the BSD and GRG positions are exempted, we will be able to extend the hours this summer, avoid closures, with no cost to the federal government. We have not yet closed any public restrooms. The park just received a cert the week of April 14, 2025 and if the other custodial vacancies are exempted from the hiring freeze, we may be able to keep all of public restrooms open.
